## TOURNAMENT RULES

1. This Tournament is conducted by THE BATT FAMILY FUN CENTER. It is open to all USBC members in good standing. ALL PARTICIPANTS WILL BE REQUIRED TO SHOW THEIR USBC CARDS. IF NO CARD YOU MUST APPLY FOR AND PURCHASE ONE BEFORE YOU ARE ALLOWED TO PARTICIPATE.
2. THIS TOURNAMENT WILL RUN starting Saturday, Oct. 16, 2021 and ending Sunday, Oct. 17, 2021.
3. No Summer League averages may be used. Entrants shall use their highest **2020-2021 yearbook average** as recorded with USBC. Those not having a yearbook average may use current average based on 21 or more games and or League standing sheet including League Officers' signatures, as of May 1, 2021. All others bowl scratch. If none of the above, the bowler must enter with a 220 average. **ALL AVERAGES MUST BE VERIFIED PRIOR TO SUBMITTING ENTRY TO TOURNAMENT MANAGER.**
4. Members of Bowling Organization known as PBA / LPBA may participate but no more than 2 per team and 1 per set of doubles. USBC Youth are not eligible to participate.
5. After an entry has been accepted by the Tournament Manager, entry fees will not be refunded.
6. Mixed Team event will consist of 4 persons as long as one person is of the opposite sex. Team entrants may bowl as often as they wish. No more than 2 members can cash together on the same team more than once. Mixed Double entrants may bowl as often as they like, cash only once with the same partner, cash again with a different partner.
7. Team Captains are responsible for notifying their team members of scheduled times to bowl. Check in will begin ONE HOUR prior to start of squad. All prize money will be sent to Team Captains 30 days after the close of the tournament for distribution to team members.
8. Prizes will be awarded at a Ratio of at least 1 prize for every 10 entries per event. Prize Fund will be returned 100%.
9. **There will be no change in the submitted original line-up.**
10. Substitutes will be allowed as long as they are eligible and have written verification of average. After a SUB has started a game, He or She will complete the SERIES. If a bowler is late for any event, a score of Zero will be given for each frame missed. The Tournament Office must be advised of substitutions at least 1 hour before scheduled bowling time. **Pacers will not be allowed.**
11. Telescope printouts will be official scores. Team captains for mixed teams and individuals for mixed doubles must sign official score sheets. Said signatures will be considered as final approval and only protests of obvious errors in transposing and addition will be considered valid.
12. Scores lost due to power or mechanical failure must be rebowled. (USBC-328)
13. Protest concerning eligibility or general playing rules shall be made in writing to the Tournament Manager. The decision of THE BATT FAMILY FUN CENTER. shall be final unless an appeal is made to USBC.
14. THE BATT FAMILY FUN CENTER shall be liable only to the extent of returning entry fees if and when the entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule change, or premature termination of the tournament, which may be brought about by War, National Emergency, or Emergencies or causes relating thereto or resulting from fires, strikes, lockouts, labor difficulties or other causes beyond our control.
15. **ALL PRIZE CHECKS must be cashed within 30 days of the date on the check.**
16. Positively no food or beverages of any kind will be allowed in the bowler's circle.
17. NO FLASH CAMERAS allowed during the tournament play. **THIS WOULD CONSTITUTE DISQUALIFICATION OF THE BOWLER.**
18. Entrants who place on the prize list must have their averages verified by November 4, 2020 by their local association or the league secretary, (if no yearbook average), and sent to the Tournament Manager. Failure to comply will result in loss of handicap and we will use scratch score only.
19. **ALL USBC RULES WILL APPLY FOR ANY RULE NOT COVERED IN THESE TOURNAMENT RULES.**
20. Reserve Team entries will close at midnight, October 4, 2021. All entries received the first Post Office business day following the entry closing date will be accepted.

**WALK-INS WILL BE ACCEPTED FOR MIXED DOUBLES ONLY. (UP TO 1 HOUR PRIOR TO LAST SQUAD!!! IF LANES ARE AVAILABLE)**

### ATTENTION BOWLERS

10 Pin rule will apply (USBC Rule 319A2) - Entrants will not be required to report previous Tournament prize winnings 319-D.

Rule 319A-3 will apply. Bowler will be responsible for verifying reported average, whether submitted by bowler, team captain or others.

Rule 319E will apply.
